



#### **Origins of Addiction in Humans**

#### ► Nature

- Genetic imprinting
- Co-occurring psychiatric disease

#### ► Nurture

- Environment (family, friends, community, era, religion)
- Co-occurring psychiatric disease

#### **COVID-19: Potential Impacts on Addiction Pathology**

- ▶ Mass psychological trauma akin to Sept 11<sup>th</sup>, natural disasters or World Wars
- ► Routines disrupted
- ▶ Fewer social cues
- ► No need to drive home


#### **COVID-19: Known Impacts on Addiction Treatment**

- ► Self-Help meetings shuttered and resumed online
- ► Addiction treatment facilities closed or severely limited admissions
- Outpatient counseling / physician visits mostly online
- ► Hard/scary to get to opioid agonist treatment programs

#### **Signs of Addiction in an Employee**

- ► Acting totally normal
- ▶ Working too much
- ► Working too little
- ► Missed deadlines
- Irritable
- ▶ Disheveled appearance
- ▶ Repeated questions ("I already told you this")
- ▶ Odd hours (challenging during quarantine)

# Roughly 22 MM people suffer from SUD/OUD in US, but only 1 in 10 seek treatment

COVID-19 has created a perfect storm that is compounding an already severe public health crisis

- Physical distancing, closure of public spaces, lack of direct social support groups, economic indicators, amid an already more vulnerable group of individuals (smoking, vaping, opioid/methamphetamines negative effects on respiratory & pulmonary systems)
- 40% of people with SUD have a co-occurring mental health disorder.
- 70% of the 14.8 MM Americans using illegal drugs are employed.
- "Just Five" compliments the "Path Forward" initiative. Employers play an important role with their workforce & communities. The general public is both undereducated and often misinformed about addiction.
